# COUNTRY GUIDE DENMARK

Once an important seat in Viking society, Denmark has evolved into one of the most prominent Scandinavian nations with a modern and one of the most stable economies in Europe. Regardless of its small size and population, Denmark holds an important role in European history dating back to the Iron Age, and to this day is still a mayor player in the general political and economic integration of Europe. While Denmark is a member of the European Union, it has opted out of certain elements of the EU's Maastricht Treaty, including adopting the Euro as its official currency.



#### **ROBUST DOMESTIC ECONOMY**

While a small country, Denmark ranks within the top 40 largest economies in the world (based on nominal GDP). Its economy is diverse with a mixture of agriculture, industry, and services. The latter accounting for about 75% of the country's GDP. Denmark's economy is characterized by a balanced state budget, stable currency, low interest rates and low inflation, making it one of the strongest in Europe.

#### **EASE OF DOING BUSINESS**

According to the World Bank's Ease of Doing Business Index, Denmark tops the ranking as the easiest place to do business in Europe and is #4 in the world. After introducing measures to improve establishment procedures to faster, more informal and cost-efficient processes, including the simplification of a number of legal procedures, Denmark has improved its offering to international businesses even further.

### **SERVICES SECTOR**

The services sector is by far the largest contributor to the Danish economy, employing about 80% of the country's population. The services sector is comprised of a strong banking sector with a high degree of concentration (over 85% of assets are owned by domestic banks), a growing tourism sector, and an important trade and transport services sector.

### ONE OF THE HAPPIEST COUNTRIES IN THE WORLD

The World Happiness survey, a report released by the UN's Sustainable Development Solutions Network, measures how happy a country's citizens perceive themselves to be. Denmark has consistently ranked at the top of this list for many years. It is currently in the second spot behind Finland.
