Individual licensees are responsible for confirming and ensuring that UpToDate may be accepted to fulfill nursing requirements. Licensees are supposed to engage in continuing education activities that provide professional growth that relevant to their professional practice. UpToDate cannot determine if credits/hours earned using UpToDate are relevant to each licensee, therefore UpToDate cannot guarantee acceptance of all credits for all licensees.
