OPEN ECONOMY

A key feature of the Swedish economy is its openness and liberal approach to trade and doing business. The World Economic Forum ranks this highly successful and diverse economy among the top ten most competitive in the world and one of the easiest to do business with.

TECH INNOVATION

Sweden has built a reputation in the tech world that rivals Silicon Valley. In the last decade, it has produced a number of widely successful start-up companies including fintech company Klarna, music streaming service Spotify, and video call platform Skype.

BANKING SECTOR

Sweden enjoys a healthy banking system which has been critical for the stability of its economy. Not only are banks highly profitable, but they have proven to be resilient to market shifts due to high capital and liquidity requirements. Sustainable finance is a high priority in Sweden. Initiatives in banking have started or are planned by both banks and the government.

MANUFACTURING

Sweden's export-oriented manufacturing industry contributes significantly to its economy. Automotive is the largest sector accounting for almost half of the output, with automakers such as Saab and Volvo recognized globally. Other areas in manufacturing include aerospace, electronics, electric plants, petrochemicals, biotech, and pharmaceuticals.
